The MOPH Fund, Inc., ("the Fund") a 501.c.3 non-profit public charity, is separate and not subordinate to the Military Order of the Purple Heart. The Fund Inc. is the official fundraising arm of the Military Order of the Purple Heart (the Order). Our sole purpose is to raise funds for programs executed by the Military Order of the Purple Heart.

The Fund has an eleven-person Board of Directors of which all but one are Purple Heart recipients and members of the Order. While separate from the Order, the Fund's bylaws require the National Commander, National Senior Vice Commander, the National Junior Vice Commander, and the six Region Commanders to be Directors on our Board.

We have engaged professional grant writers and just this month have submitted proposals totaling \$600K to different nationally recognized organizations. The Fund tries to ensure we find programs that will DIRECTLY BENEFIT CHAPTERS and the National Headquarters programs. While not every program will have the same revenue sharing formula, the Fund's programs are designed to reward the Chapters for the work they do to make the programs work.

Bills in Congress

H.R.4566, the Providing Radiation Exposed Servicemembers Undisputed Medical Eligibility (PRESUME) Act would eliminate VA's current practice of requiring radiation dose estimates for veterans claiming diseases related to radiation exposure. Currently, VA requires proof of the veteran's onsite participation at a radiation risk activity, but also radiation dose estimates from the Defense Reduction Agency and a medical opinion indicating the dose estimate caused the claimed presumptive disease.

The Department of Justice (DOJ), Radiation Exposure Claims Act (RECA) program does not require claimants to prove causation of the diseases related to the radiation exposure, nor does it require dose estimates of exposures. Veterans who were exposed onsite can receive compensation from the government without dose estimates and without proving that the claimed disease is directly caused by the dose estimate of radiation exposure.

Radiation exposed veterans are held to a higher standard by the VA, than the DOJ for civilians exposed to radiation. This unfair practice must be halted. Urge your representatives to support HR4566.

The Maternal Health for Veterans Act (S. 2026) would strengthen oversight of the Department of Veterans Affairs (VA) maternity care coordination efforts while authorizing new funding to make sure VA has the resources it needs to provide women veterans with access to the maternal care they've earned through their service. The legislation also requires the VA to

PACT Act

The *PACT Act* is a law that expands VA health care and benefits for Veterans exposed to burn pits, Agent Orange, and other toxic substances. There's no deadline to apply for PACT Act benefits. But if you file your PACT Act claim or quickly submit your intent to file by **August 9, 2023**, you may receive benefits backdated to August 10, 2022. So don't wait, apply today.

VA Co-Pay Exemptions for Native Americans

Beginning April 4, 2023, eligible American Indian and Alaska Native Veterans no longer must pay a copay for VA health care services and urgent care. And we'll review copays we received for report data on maternal health outcomes of veterans who receive medical care at a VA health facility or community care provider. Additionally, it requires recommendations by the VA to improve the maternal health outcomes of veterans. Urge your senator to support S. 2026.

The Major Richard Star Act (S. 344) is bipartisan legislation that would authorize concurrent receipt of Department of Defense (DoD) retired pay and Department of Veterans Affairs (VA) disability compensation for those injured in a combat zone and medically retired under Chapter 61 of title 10, United States Code.

In April, we asked for your support on this standalone bill. Now, we need you to contact your Senators to vote for adoption of Amendment 142 provisions from the Major Richard Star Act so it can be included in the National Defense Authorization Act (NDAA). This benefit would eliminate this unjust offset of disability compensation for combat-injured military retirees.

S. 1635/H.R. 3718 calls for updated training for Department of Veterans Affairs claims processors who review claims for service-connection for posttraumatic stress disorder. Training would include instruction on stressors development and verification and be standardized across VA regional offices. The legislation would also require VA to establish a formal process to review claims decisions annually to determine if updates to the training program are warranted. Urge your senator & representative to support this legislation.

The Love Lives on Act in the Senate now has a companion bill in the House of Representatives, H.R. 3651—the Love Lives On Act. This legislation would eliminate the remarriage age for survivors in receipt of Dependency Indemnity Compensation (DIC). For decades, surviving spouses were not able to maintain their DIC if they remarried prior to the age of 55. The payment of DIC benefits provides surviving spouses with the means to maintain some semblance of economic stability for themselves and their families. Please contact your Representative to co-sponsor and support H.R. 3651.

HB 2062 Vehicle license tax exemption for PH veterans:

On registration of a vehicle, if the veteran



submits satisfactory proof to ADOT that the person is a veteran and a bona fide purple heart medal recipient and was honorably discharged vehicle registration tax fee is waived. Can only be used on one vehicle. Specialty plate and personalization fees still apply.



Order of Purple Heart

Recognition for AlL

By direction of President Hoover, the War Department today reinstituted the ancient Order of the Purple Heart. established by Gen. George Washington at Newburgh, N. Y. August 7. 1782. during the War of the Revolution. The 200th anniversary of Gen. Wash-ington's birth was selected as the most appropriate occasion for the revival of the Purple Heart decoration, the first honor backs in the history of the United States Army provided for the enlisted man and the non-commis-sioned officer.

enlisted man and the non-commis-sioned officer. Under the liberal ruling of the War Department thousands of soldiers and ex-soldiers will become eligible for this honor, which has been awarded in the past to only three men for merit-rious acts and service. These men were Sergt Daniel Bissell of the 2d Connecti-cut Reciment of the Continental Line Sergt. Daniel Bissel of the 2d Connecti-cut Regiment of the Continental Line, Sergt. Daniel Brown of the 5th Con-necticut Regiment and Sergt. Elijah Churchill of the 2nd Continental Dragoons, which also was a Connecticut regiment

Wounded to Get Award.

Wounded to Get Award. Under changes in Army regulations, award of the <u>Purple Heart</u> is author-ized to persons who "while serving in the Army of the United States perform any singularly meritorious act of extraordinary fidelity or essential serv-ice." Wounds received in action are included in this category. It must be awarded within three years of the per-formance of the act and is not to be awarded posthumously. For service prior to February 22. 1832, the **Purple Heart** will be awarded to men who earned the meritorious service citation certificate during the World War and to those who also are authorized to wear wound chevrons. The revired decoration consists of a heart-shaped medal, its face gold bor-dered and its center of purple enamel. On the obverse is a relief bust of George Washington in the uniform of a general of the Continential Army. Its reverse is gold with the inscription "For Military Merit." The Washington rot of arms is incorporated in the ring which attaches it to a purple rh-bon, bordered with white. General Orders No. 3, under which Washington established the Purple Heart, lead as follows:

Recognition for All. "The general ever desirous to cherish a virtuous ambition in his soldier, as well as to foster and encourage every species of military merit, directs that whenever any singularly meritorious ac-tion is performed, the author of it shall be permitted to wear on his facings over the left breast, the figure of a heart in purple cloth or silk, edged with narrow lace or binding. Not only instances of unusual gallantry, but also of extraordinary fidelity and essential service in any way shall meet with a due reward. Before this favor cas be conferred on any man, the particular fact, or facts, on which it is to be prounded must be set forth to the Commander-in-Chief, accompanied with certificates from the commanding offi-cers of the regiment and brigade to which the candidate for reward be-longed, or other incontestable proof-and upon granting it, the name and regiment of the person with the action so certified are to be enrolled in the Book of Merit, which will be kept at the orderly office. Men who have merited this last distinction to be suf-fered to pass all guards and sentinels which officers are permitted to do. "The road to glory in a patriot army shis order is also to have retrospect to the earliest stages of the war and to be considered as a permanent one."
